Many items are held in stock but we suggest that you allow three to six weeks for production and delivery.

Please note that all designs are sold in multiples of three.

1) Retention of Title

a) The Goods shall be at the Customer's risk as from delivery.

b) All Goods remain the property of Angelic Hen until:

(i) the Customer shall have paid the price plus any VAT in full and

(ii) no other sums whatever shall be due from the

Customer to Angelic Hen.

c) Until property in the Goods passes to the Customer in accordance with 1b the Customer shall hold the Goods and each of them on a fiduciary basis as bailee for Angelic Hen. The Customer shall store the Goods (at no cost to Angelic Hen) separately from other goods in its possession and marked in such a way that they are clearly identified as Angelic Hen's property.
d) Until augh time as the property of the Coods

d) Until such time as the property of the Goods passes from Angelic Hen, the Customer shall upon request deliver up such of the Goods as have not

ceased to be in existence or resold to Angelic Hen. If the Customer fail to do so, Angelic Hen may enter upon any premises owned or controlled by the Customer where the goods are situated and reposes the Goods.

e) The Customer shall insure and keep insured the Goods to the full price against "all risks" to the reasonable satisfaction of Angelic Hen until the date that property in the Goods passes from Angelic Hen, and shall whenever requested by Angelic Hen produce a copy of the policy of insurance. Without prejudice to the other rights of Angelic Hen, if the Customer fails to do so all

sums whatever owing by the Customer to Angelic Hen shall forthwith become due and payable.

2) Payment Term

Unless otherwise agreed in writing, the Customer shall make full payment for the Goods within 30 days of the invoice date.

3) Interest Charges

If payment is not made by the due date Angelic Hen may, without prejudice to its other rights, charge interest at a monthly rate of 3% above Lloyds TSB base rate on any outstanding balances until payment is made in full.

4) Right to charge recovery costs

Any costs incurred in recovering the overdue accounts will be charged at cost.

5) Damages

All Goods are to be inspected by the Customer on receipt and any claims for shortages/damages must be made in writing within seven days. Angelic Hen shall have no liability to the Customer in respect of shortages/damages unless the Customer gives the said notice.

6) Right to modify

Angelic Hen reserves the right to modify specifications, designs, material and finishes of any Goods at any time without notice.

7) Carriage Costs

a) Carriage costs will be applied at time of placing the order and may vary without notice.b) If no one is available to receive delivered goods during standard working hours then the cost of repeat deliveries will be incurred by the
